Please find attached, an amendment application for the Northland Power Cochrane Solar Farm Project REA #1290-9A4KSE.

The amendment request is to have the Ministry of the Environment "accept and add into our REA approval" two Archaeological Assessment reports.

The first Archaeological Assessment report is designated Project Information Number P052-466-2013, dated January 14, 2014. This assessment report is related mainly to archaeologically clearing the previously difficult to reach areas of the Project site. These areas are within the original REA project boundary and the MNR also considered these areas as part of their original Natural Heritage Assessment. There is one small segment of land (a triangle approximately 40 m x 40 m x 55 m) which is being assessed by the MNR, as the land is needed to ensure that the collector line crossing is legal at a property corner.

The second Archaeological Assessment report is designated Project Information Number P052-453-2013, dated September 16, 2013. This includes an assessment of lands at the interconnection point with the HONI grid, which is approximately 20 km west of the Project site. These lands were already included in the original REA application and the original MNR Natural Heritage Assessment, but were not fully examined originally by the consultant archaeologist. This report has also been submitted as part of another REA amendment application (Long Lake REA #8430-9AEQ6M, MOE Reference number 1001-9FBT7P) and is being included here for completeness of this stand-alone REA permit.

Please find attached to this cover letter, an amendment cover letter/report (modification document) on Hatch letterhead dated April 16, 2014.

3. Complete Submission

 - are to be submitted as part of the application for the purposes of obtaining an exemption from a provision of Part V; and
 comply with all other requirements of Part IV of Ontario Regulation 359/09.
- 3) If there is more than one person applying for the issue of a renewable energy approval in respect of a renewable energy project, those persons shall jointly submit one application for the issue of a renewable energy approval.
- 4) An application to alter the terms and conditions of a renewable energy approval shall be prepared in a form or format approved by the Director and shall be submitted to the Director.

Supporting documents

- A person who proposes to engage in a renewable energy project shall submit a document set out in Column 1 of Table 1 of the Regulation as part of an application for the issue of a renewable energy approval in respect of the project if it is a project described opposite the document in Column 3.
- 2) If a document set out in Column 1 of Table 1 of the Regulation is submitted as part of an application for the issue of a renewable energy approval, the person who is engaging in the renewable energy project shall ensure that the document meets the requirements set out opposite the document in Column 2 of Table 1 of the Regulation.
- 3) Any document submitted as part of an application for the issue of a renewable energy approval shall be in writing.
- 4) Any document submitted as part of an application for the issue of a renewable energy approval that is a diagram, map or plan shall be drawn to scale and shall include a scale bar and a north arrow.

The Ministry may require additional information during the technical review of any application.

Project Description Summary

(This summary should reflect the description in the documents upon which consultation has been completed and if it does not, the difference should be highlighted) The facility is a 30 MW solar generating facility, located in the Town of Cochrane and the unorganized townships of Calder and Clute. The project will generate electricity using photo-voltaic panels mounted on fixed racking structures. Electricity generated by the solar photo-voltaic panels will be converted from direct current to alternating current by an inverter, and increased to 27.6 kV by the inverter house transformer, and subsequently stepped up (via the substation transformer) to 115 kV prior to being connected to the Project's transmission line. An approximately 20 km transmission line will be constructed from the facility location, progressing west to the connecting point with the HONI electricity grid. Other project components include access roads, a control building and site fencing.
